


### Ben Willis Healthcare Partner VWV

A former Chief Political Correspondent, he has also been a BBC Network News correspondent and has presented a wide range of television and radio programmes, in Welsh and English.

#### Political history

In the time since he was first returned Rhun has served as Shadow Minister for the Economy and Transport, Health and Care, and Finance, and as a member of the corresponding Assembly and Senedd committees. He currently holds Plaid Cymru's Health and Care brief.

He has been Deputy Leader of the Plaid Cymru Group since 2018, and was recently selected to stand in the Ynys Môn constituency at the next Westminster general election.
